THIS AGREEMENT is made and entered into on the last date executed below, by and between the North Carolina Department of Transportation, an agency of the State of North Carolina, hereinafter referred to as the "Department", and the Town of Pittsboro, hereinafter referred to as the "Municipality."

**WITNESSETH:**

WHEREAS, the Department and the Municipality on 10/6/2014, entered into a certain Project Agreement for the original scope: construction of new concrete sidewalk along SR 1967 (Pittsboro Elementary School Road) in Pittsboro, Chatham County, programmed under WBS Element 3608.3.07; and,

WHEREAS, the parties have agreed to extend the completion date to June 30, 2016 in lieu of October 6, 2015;

NOW THEREFORE, the parties wish to supplement the aforementioned Agreement whereby the following provisions are amended:

**TIME FRAME**

The Municipality shall complete said work by June 30, 2016.

Except as hereinabove provided, the Agreement heretofore executed by the Department and the Municipality on 10/6/2014, is ratified and affirmed as therein provided.
