

AN ORDINANCE AUTHORIZING AN EXTENSION OF THE  
EXTRATERRITORIAL PLANNING JURISDICTION OF THE TOWN OF  
PITTSBORO

WHEREAS, the Charter of the Town of Pittsboro in Article XV thereof provides for a defined area known as "extraterritorial planning jurisdiction" to extend not more than one mile outside the corporate limits wherein the powers granted by Article 19, Chapter 160A of the General Statutes may be exercised; and

WHEREAS, pursuant to Section 15.1 of the Town's Charter, as amended by Chapter 415 of the 1989 Session Laws, the Town may exercise said powers beyond the one mile boundary with the consent of the Board of Commissioners of Chatham County; and

WHEREAS, the Town of Pittsboro and the County of Chatham have previously agreed upon the limit of said extraterritorial planning jurisdiction more than one mile beyond the town's corporate boundary; and

WHEREAS, Chatham Park Investors LLC, the owner of various tracts or parcels of land within and adjacent to the existing extraterritorial planning jurisdiction limits of the Town of Pittsboro has requested that those limits be extended to include all of its parcels of property which are more particular identified on Exhibit A attached hereto and incorporated herein by reference; and

WHEREAS, said properties are currently being considered for development and are subject therefore to possible review by both the Town and County; and

WHEREAS, the applicable standards of review, the fees, and administrative procedures for each jurisdiction are dissimilar; and

WHEREAS, development of said properties deserves a consistent, comprehensive review by one jurisdiction in order to minimize confusion and dissimilar standards; and

WHEREAS, Chatham County consented to the extension of the Town's extraterritorial planning jurisdiction limits as requested by the owner of the lands within the defined area to be added; and

WHEREAS, the Town of Pittsboro is willing to accept such property within its extraterritorial planning jurisdiction in order to provide comprehensive and uniform application of the powers exercised by the Town therein; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Town of Pittsboro that the property requested by Chatham Partners, LLC be included within and by extension of the Town's extraterritorial planning jurisdiction, as described on Exhibit A hereof.

**EXHIBIT A  
PITTSBORO ETJ EXTENSION  
PROPERTY OF CHATHAM PARK INVESTORS LLC**

(NOTES: All recording references in this Exhibit A are to the Register of Deeds for Chatham County, North Carolina. Chatham Park Investors LLC is referred to herein as "CPI". Some of the lines along the northern boundary of the property described in this Exhibit A were calculated and not surveyed; accordingly, the exact metes and bounds of one or more of such boundary lines may not exactly match the metes and bounds of the adjoining property that previously has been included in the Town of Pittsboro ETJ. It is the intent of the description in this Exhibit A to include in the Town of Pittsboro ETJ all of the property owned by Chatham Park Investors LLC that is located south of the property of Chatham Park Investors LLC (and possibly one or two other others) that already is subject to the Town of Pittsboro ETJ.)

Beginning at point in the center line of Pittsboro-Moncure Road (North Carolina State Road 1012), a common corner with the southwest corner of property acquired by CPI from H. D. Gunter, Jr. et al. by deed ("Gunter Tract") recorded in Book 1357, Page 258, and also being a corner of property acquired by CPI by deed recorded in Book 1231, Page 560 ("Harper Tract"); then with the southern boundary line of the Gunter Tract, North 80°20'16" East 55.73 feet to a point;  
then continuing with the southern boundary line of the Gunter Tract, North 80°20'16" East 3280.03 feet to a point at the southeast corner of the Gunter Tract;  
then the following two (2) lines through the Harper Tract:  
(1) South 37°48'56" East 768.58 feet to a point, and  
(2) North 89°28'24" East 554.26 feet to a point in the western boundary line of property acquired by CPI from Hilda M. Small by deed recorded in Book 1380, Page 1067 ("Small Tract 1");

then with the northern boundary line of Small Tract 1, South 88°31'47" East 577.79 feet to a point and North 20°01'02" West 881.81 feet to a point,  
then continuing with the northern boundary line first of Small Tract 1 and then with another tract acquired by CPI from Small by deed recorded in Book 1438, Page 13 ("Small Tract 2), South 89°46'19" East 2054.01 feet to a point and South 89°46'19" East 886.11 feet to a point;  
then with the eastern boundary line of Small Tract 2, South 02°20'29" East 199.41 feet to a point;  
then the following lines through the Harper Tract:  
(1) South 89°15'16" East 825.94 feet to a point,  
(2) North 00°17'02" East 1137.75 feet to a point,  
(3) South 89°06'23" East 1484.83 feet to a point,  
(4) South 01°40'57" West 192.15 feet to a point,

(6) North 00°03'00" East 1823.80 feet to a point, and  
(7) North 90°00'00" East 2690.88 feet to a point on the center line of the right of way of Gum Springs Church Road (NC State Road 1943) in the western boundary line of property acquired by CPI from Clifford Bryce Selkinghouse et al. by deed recorded in Book 1300, Page 537 ("Selkinghouse Tract");

then along the center line of Gum Springs Church Road, first with the western boundary line of the Selkinghouse Tract and then with the western boundary line of property acquired by CPI from Wilbur Moore and Willodeen G. Wagner by deed recorded in Book 1291, Page 1068 ("Moore Tract), the following nine (9) lines:
